Overview: North Side, 1000 Blocks of Mulholland

The block west of the Temple Block was really never a part of Mulholland's business district. The 1891 Plat and 1912 Sanborn Maps note that a few buildings lined Wells (11th) Street. Vineyards covered the west half of the block at that time. However, in 1874, the Sisters of St. Benedict "came to town," and everything on this block and the block directly north of it changed.

1000 Blocks, North Side of Mulholland

Note: "Block" is delineated by Mulholland, Knight (vacated), Durphy (10th), and Wells (11th)

1891 Plat:

A. Lumber [on corner of Mulholland and Wells (11th)]

B. Hardware [directly north of "A"]

C. Restaurant [directly south of "D"]

D. Millinery [on corner of Wells (11th) and Knight Streets]

1912 Sanborn Map:

Vacant brick building [former State Bank of Nauvoo/Spalding Institute] [Same location as "B," above]

Brick dwelling [Masberg residence-pharmacy (same location as "D" above)]

2010: Green Space

Note: The following "block" is north of the above and delineated by Knight (vacated), Young, Durphy (10th), and Wells (11th)

The Sisters of St. Benedict in Nauvoo 1874-2001

Little did anyone know that when five Catholic Sisters came to teach in Nauvoo in 1874 at the invitation of the parish priest, just what their future in Nauvoo would be. By 1907, thirty-three years after their arrival, they had amassed the equivalency of six blocks on and near Wells Street at the west end of Mulholland's business district. Over the years they oversaw an academy that, over time, was housed in three different buildings, as well as a school for boys up to twelve years of age. They purchased several nearby buildings, which, at various times, housed classrooms, students, and the Sisters.


All of their properties went into foreclosure in 1920, but they persevered; and by 1939, they had satisfied the creditors and all properties were, once again, theirs.

From 1874 to the closure of St. Mary's Academy in 1997, the Sisters of St. Benedict continued to maintain their Motherhouse in Nauvoo, as well as to expand their educational offerings to the community and to a multitude of students from grade to high school. Their boarding school for girls provided an education for up to 150 girls per semester. In 1996, the Monastery and Academy jointly employed 54 full- and part-time lay people, the number of employees second only to the Nauvoo Cheese Factory.

In 1999, the Sisters sold the majority of their properties along Wells Street to the Church of Jesus Christ of Latterday Saints. In 2001, after 127 years in Nauvoo, they moved into their newly constructed St. Mary Monastery, in Rock Island, Illinois.



St. Mary's Academy 1897-1967



The two blocks between Mulholland and Young Streets were connected as one when Knight Street was closed in the 1950's to accommodate the expansion of St. Mary's Academy and Priory/St. Mary Monastery. Additional properties were located on adjoining blocks.

The Sisters used several existing buildings for their school and priory before expanding into newer facilities. Among them were (E) the former State Bank of Nauvoo. (F) Cambre House, and (I) the former Masberg home.

E. Former location of the State Bank of Nauvoo (1893-1896)/Spalding Institute's first location (1904)

By the time the 1912 Sanborn Map appeared, the State Bank of Nauvoo (at this site 1893-1896) had moved to its present location, but the building remained. (The building was first rented (1904) then, sold to the Sisters of St. Benedict (1905), who used it as the startup location of Spalding Institute (See Information Sheet # 2 on the Walking Tour). It also housed some of the students. Razed: 1939






F. Cambre House, a former Icarian building of the 1850's. In 1905, the "Cambre House," as well as the whole block, except for the northwest corner lot where the Blum house stood, was willed to the Sisters. The house was used mainly as storage and, occasionally. as a residence for the Priory chaplain or the Sisters. It remains.



I. Masberg Pharmacy and Residence in 1876 In 1916, the residence was used as a parochial school, where the Sisters taught all grades and two years of high school to forty pupils under the direction of Sts. Peter and Paul's Father Tholen. In 1945, the Sisters purchased the old Masberg building. Razed: 1947

1967 Aerial View of St. Mary Priory and Academy Complex

A. In 1874, the Sisters purchased the Frederick Baum residence, which had formerly served the Mormons as an arsenal and the Icarians as a wagon shop, to house their first school and convent. Initially called "St. Scholastica," the building was renamed "St. Mary's Academy and Convent" when the Sisters became an independent Motherhouse in 1879. Below, a later view of St. Scholastica/St. Mary's Academy and Convent, showing modifications to the original building. Razed: 1967



C. St. Mary's Academy

St. Mary's Academy, a new and expanded facility, was built in 1897 to accommodate the Academy's growing enrollment. It incorporated both classrooms and dormitory space for Academy girls until 1955 when a newer, larger facility took its place. The building continued to be used for lounge areas and a dormitory until 1967. Razed: 1967

By 1949, only "Rose Cottage" (See "B" on Diagram of Sisters' Properties) remained on the block, which was mainly covered by orchard and vineyard. Within ten years, the landscape would include the new quarters of St. Mary Priory/Monastery. Across the street (A) is Sts. Peter and Paul Grade School and (G) the former Spalding Institute.



H. St. Joseph "Joe" Hall Built as a power plant in 1907 for the Priory/Academy complex, the building's second and third floors were used as a dormitory. Razed 2007.



Presently it is owned by Sts. Peter and Paul parish and used as a rectory. In 1999, the Sisters sold the majority of their properties along Wells Street to the Church of Jesus Christ of Latter-day Saints. The oldest-known, available photograph of the building the Sisters called "Villa Marie". It was built as a house and store for Mormon, Parley P. Pratt in 1839, purchased by Sts. Peter and Paul parish in 1851, lost to foreclosure in 1920, stood empty from 1915-1920, regained by the parish in 1938, and purchased by the Sisters the same year. The "Villa" was used as a residence for students and
